History of Visiting Scholar in Residence Lecture

The visiting scholar in residence program is designed to introduce newer and promising scholars in corporate and business law to the Delaware bench and bar, so that the bench and bar can benefit from their scholarly insights and so that they can enrich their scholarship with feedback from Delaware's internationally renowned legal community. The program has created strong bonds between that community and future leaders in the law school community.

Afra Afsharipour is Professor of Law and Martin Luther King, Jr. Hall Research Scholar at University of California, Davis School of Law. She teaches courses in business associations, business planning, antitrust, and mergers and acquisitions. Professor Afsharipour is widely published and lectures frequently on various topics involving comparative corporate law, corporate governance, mergers and acquisitions, transactional law, and related issues. Her scholarship has appeared in a number of law reviews, including *Columbia Law Review*, *Minnesota Law Review*, *Vanderbilt Law Review*, and *UC Davis Law Review*. She is chair-elect of the Transactional Law and Skills section of the Association of American Law Schools and serves on the executive committee of the Law and South Asian Studies section. Previously she was an attorney at Davis Polk & Wardwell, where she advised clients on domestic and cross-border mergers and acquisitions, public and private securities offerings, and corporate governance and compliance matters. She also served as a law clerk to the Honorable Rosemary Barkett of the U.S. Court of Appeals for the Eleventh Circuit. She received her JD from Columbia Law School, where she was named a Harlan Fiske Stone Scholar, and a BA, magna cum laude, from Cornell University.

Her topic, Deal Advisors, will examine the role of financial and legal advisors in merger and acquisition transactions, a topic that has received a great deal of attention in recent Delaware litigation, notably in the Rural Metro case.
