

THEMIS OFFER (OFFER EXPIRES OCTOBER 1st)

Themis Bar Review regular price -- \$1,795 single state, \$1,995 combo course (PA/NJ etc.)

Public Interest Scholarship: \$600 off. Final price of \$1,195 or \$1,395 combo course. Anyone going into a clerkship, government work, DA/PD offices, and similar will qualify. Email pennsylvania@themisbar.com for the enrollment form.
